AMENDMENTS

Intended to be proposed by Mr. TOWER to S. 3044, a bill to amend the Federal Election Campaign Act of 1971 to provide for public financing of primary and general election campaigns for Federal elective office, and to amend certain other provisions of law relating to the financing and conduct of such campaigns, viz:

1 On page 28, line 16, strike out the quotation marks and
2 the second semicolon.

3 On page 28, between lines 16 and 17, insert the follow-
4 ing: "but does not mean a corporation or labor organization
5 which makes contributions or expenditures to establish, ad-
6 minister, or solicit contributions to a separate segregated fund
7 described in section 610 of title 18, United States Code;".

1 On page 29, line 1, strike out "other than" and insert in
2 lieu thereof "including".

3 On page 30, between lines 16 and 17, insert the following:

4 “(2) means any payment or obligation incurred by
5 a corporation or labor organization which, under the
6 provisions of the last paragraph of section 610 of title 18,
7 United States Code, is not an expenditure by that cor-
8 poration or labor organization;”.

9 On page 30, line 17, strike out “(2)” and insert in lieu
10 thereof “(3)”.

11 On page 30, strike out lines 19 and 20 and insert in
12 lieu thereof the following: “(4) does not include the value
13 of services rendered by individuals”.

14 On page 30, line 22, strike out “or” and insert in lieu
15 thereof closing quotation marks and a semicolon.

16 On page 30, beginning with line 23, strike out through
17 line 2 on page 31.

18 On page 39, line 2, strike out the quotation marks and
19 the second period.

20 On page 39, between lines 2 and 3, insert the following:

21 “(f) Every corporation and labor organization which
22 makes contributions or expenditures for the establishment,
23 administration, and solicitation of contributions to a separate
24 segregated fund as described in section 610 of title 18,

1 United States Code, shall file reports with the Commission
2 at the same times and containing the same information as
3 the reports required of political committees under this
4 section.”.
