Modification

DISH Operating L.L.C. seeks to extend the expiration date, until April 22, 2022, for its authorization to operate the EchoStar 7 Direct Broadcast Satellite space station at the 118.9° W.L. orbital location using DBS channels 1-21 in the 12.2-12.7 GHz (space-to-Earth) and 17.3-17.8 GHz (Earth-to-space) frequency bands. This authority currently expires on April 22, 2012. DISH is operating EchoStar 7 at 118.8° W.L., rather than its assigned location at 118.9° W.L., pursuant to special temporary authority. IBFS File No. SAT-STA-20120119-00007. DISH also has a request pending to modify its authorization to specify operations at 118.8° W.L., see IBFS File No. SAT-MOD-20100329-00058, and asks that any extension granted be applied to operations at that location.
