## NOTICE OF DOMESTIC SECTION 214 AUTHORIZATIONS GRANTED

### WC Docket Nos. 13-223 & 13-228

Pursuant to section 214 of the Communications Act of 1934, as amended, 47 U.S.C. § 214, and sections 0.91, 0.291, and 63.03 of the Commission's rules, 47 C.F.R. §§ 0.91, 0.291, and 63.03, the Wireline Competition Bureau (Bureau) approves the transfer of control applications listed below.<sup>1</sup> No commenter opposed grant of these applications, and the Bureau finds that the proposed transfers will serve the public interest, convenience, and necessity, and therefore grants the requested authorizations.<sup>2</sup> For purposes of computation of time when filing a petition for reconsideration or application for review, or for judicial review of the Commission's decision, the date of "public notice" shall be the release date of this notice.<sup>3</sup>
