On October 30, 2013, the Public Safety and Homeland Security Bureau (Bureau) released a *Public Notice*<sup>1</sup> seeking comment on the 4.9 GHz National Plan Recommendations Final Report submitted by the National Public Safety Telecommunications Council (NPSTC) on October 24, 2013.<sup>2</sup> The *Public Notice* contained incorrect comment filing procedures and information about availability of documents. Accordingly, we correct this information and extend the comment due date from November 22, 2013 to November 26, 2013. The reply comment due date remains unchanged.

Interested parties may file comments and reply comments on or before the dates indicated on the first page of this document. Interested parties may file comments using: (1) the Commission's Electronic Comment Filing System (ECFS), or (2) by filing paper copies. *See Electronic Filing of Documents in Rulemaking Proceedings*, 63 FR 24121 (1998). **Commenters should refer to the docket numbers and the DA number on the front page of this Public Notice when filing comments.**
