AT&T MOBILITY SPECTRUM LLC AND CABLE ONE, INC. SEEK FCC CONSENT TO THE ASSIGNMENT OF ADVANCED WIRELESS SERVICES LICENSES FROM CABLE ONE TO AT&T MOBILITY SPECTRUM

I. INTRODUCTION

AT&T Mobility Spectrum LLC (“AT&T Mobility Spectrum”), an indirect wholly-owned subsidiary of AT&T Inc. (collectively with AT&T Mobility Spectrum, “AT&T”), and Cable One, Inc. (“Cable One,” and together with AT&T, the “Applicants”), have filed an application pursuant to Section 310(d) of the Communications Act of 1934, as amended,¹ seeking approval of the assignment of Advanced Wireless Services (“AWS-1”) A Block spectrum licenses from Cable One to AT&T Mobility Spectrum. The subject licenses cover geographic areas scattered throughout the country.

The Applicants assert that the proposed assignment would serve the public interest because it would enable AT&T to increase its system capacity to enhance existing services, better accommodate its overall growth, and facilitate the provision of additional products and services to the public in the geographic areas authorized under the licenses. The Applicants represent that the additional spectrum would be used to deploy AT&T’s 4G network using Long Term Evolution technology and would increase network capacity to the benefit of all AT&T subscribers.

Preliminary review of the application indicates that the proposed transaction involves the assignment of 20 megahertz of AWS-1 A Block spectrum from Cable One to AT&T in 119 counties in 24 Cellular Market Areas (“CMAs”) across parts of various states. Post-transaction, AT&T would hold a total of 63 to 153 megahertz of spectrum in the CMAs involved in this transaction, including 20 to 50 megahertz of AWS-1 spectrum.

III. EX PARTE STATUS OF THIS PROCEEDING

Pursuant to Section 1.1200(a) of the Commission's rules,² the Commission may adopt modified or more stringent *ex parte* procedures in particular proceedings if the public interest so requires. We announce that this proceeding will be governed by permit-but-disclose *ex parte* procedures that are applicable to non-restricted proceedings under Section 1.1206 of the Commission's rules.³

Parties making oral *ex parte* presentations are directed to the Commission's revised *ex parte* rules. Parties are reminded that memoranda summarizing the presentation must contain the presentation's substance and not merely list the subjects discussed.⁴ More than a one- or two-sentence description of the views and arguments presented is generally required.⁵ Other rules pertaining to oral and written presentations are set forth in Section 1.1206(b) as well.⁶

IV. GENERAL INFORMATION

The assignment application referenced herein has been found, upon initial review, to be acceptable for filing. The Commission reserves the right to return any application if, upon further examination, it is determined to be defective and not in conformance with the Commission's rules or policies.

Interested parties must file petitions to deny no later than **February 20, 2014**. Persons and entities that file petitions to deny become parties to the proceeding. They may participate fully in the proceeding, including seeking access to any confidential information that may be filed under a protective order, seeking reconsideration of decisions, and filing appeals of a final decision to the courts. Oppositions to such pleadings must be filed no later than **March 3, 2014**. Replies to such pleadings must be filed no later than **March 10, 2014**. All filings concerning matters referenced in this Public Notice should refer to ULS File No. 0006067655.

To allow the Commission to consider fully all substantive issues regarding the Applications in as timely and efficient a manner as possible, petitioners and commenters should raise all issues in their initial filings. New issues may not be raised in responses or replies.⁷ A party or interested person seeking to raise a new issue after the pleading cycle has closed must show good cause why it

was not possible for it to have raised the issue previously. Submissions after the pleading cycle has closed that seek to raise new issues based on new facts or newly discovered facts should be filed within 15 days after such facts are discovered. Absent such a showing of good cause, any issues not timely raised may be disregarded by the Commission.

Under the Commission's current procedures for the submission of filings and other documents,⁸ submissions in this matter may be filed electronically through the Commission's Universal Licensing System ("ULS") or by hand delivery to the Commission.
