On February 26, 2014, the Satellite Division granted, with conditions, special temporary authority to Intelsat License LLC, for a period of 60 days, to continue to: (1) provide Fixed-Satellite Service in the 3700-4200 MHz (space-to-Earth), 5925-6425 MHz (Earth-to-space), 11.45-11.7 GHz (space-to-Earth), 11.7-12.2 GHz (space-to-Earth), and 14.0-14.5 GHz (Earth-to-space) frequency bands; and (2) conduct telemetry, tracking, and command operations necessary to maintain the Intelsat 9 space station at the 43.10° W.L. orbital location using the following center frequencies: 11.7005 GHz (space-to-Earth), 11.7025 GHz (space-to-Earth), 14.4945 GHz (Earth-to-space), and 14.0005 GHz (Earth-to-space).
