**PUBLIC SAFETY AND HOMELAND SECURITY BUREAU ANNOUNCES  
REGION 28 (EASTERN PENNSYLVANIA, SOUTHERN NEW JERSEY AND DELAWARE  
AREA) PUBLIC SAFETY REGIONAL PLANNING COMMITTEES TO HOLD 800 MHZ  
NPSPAC AND 700 MHZ MEETINGS**

The Region 28 (Delaware, Eastern Pennsylvania, and Southern New Jersey Area) Public Safety Regional Planning Committees (RPCs)<sup>1</sup> will hold two planning meetings on Tuesday, January 13, 2015. Both of the Region 28 Public Safety Regional Planning Committee meetings are open to the public. All eligible public safety providers whose sole purpose or principal purpose is to protect the safety of life, health, or property within Region 28 would utilize these frequencies. It is essential that not only public safety, but all government, Native American Tribal, and non-governmental organizations eligible under Section 90.523 of the Commission's Rules be represented in order to ensure that each agency's future spectrum needs are considered in the allocation process. Administrators who are not conversant with telecommunications technology should ensure that their respective agencies are represented by suitably conversant staff.

All interested parties wishing to participate in the planning for the use of the Public Safety spectrum in the 700 MHz band and 800 MHz NPSPEC spectrum within Region 28 are encouraged to attend.
