**Implementation Date:** On or after August 26, 2016

**Description of the Planned Network Change(s):**

Verizon New York Inc. is making network changes that will enable delivery of the calling party number (CPN) to the called party through Caller ID technology even where a CPN blocking option has been activated by the caller. At this time, these network changes are being implemented only for one New York customer, a volunteer ambulance service, and only for calls to the emergency telephone numbers of that customer. The customer has obtained waivers of Caller ID blocking requirements from the Federal Communications Commission and the New York Public Service Commission. In the future, Verizon New York Inc. may be required to implement this network change for other similarly-situated customers that obtain waivers of Caller ID blocking requirements from the Federal Communications Commission and the New York Public Service Commission.

**Description of Reasonably Foreseeable Impact(s) of the Planned Change(s):**

Service providers and any other affected carriers will need to be aware that their customers' CPN will be passed on calls to certain emergency service telephone numbers even though their customer has activated a CPN blocking option. The delivery of their customers' CPN to the called party where a CPN blocking option has been activated will only occur where such delivery has been required or authorized by appropriate regulatory authorities.
