## **FEDERAL-STATE JOINT BOARD ON UNIVERSAL SERVICE ANNOUNCES RURAL TASK FORCE MEMBERS**

**CC Docket 96-45**

### **Background**

In its Report and Order on Universal Service,<sup>1</sup> released May 8, 1997, the Commission, acting on the recommendation of the Federal-State Joint Board on Universal Service (the Joint Board), encouraged the Joint Board to establish a Rural Task Force (RTF) to "provide valuable assistance in identifying the issues unique to rural carriers and analyzing the appropriateness of proxy cost models for rural carriers."<sup>2</sup> On September 17, 1997, the Joint Board released a Public Notice announcing the creation of a RTF and soliciting nominations for membership.<sup>3</sup>

In the September 17 Public Notice, the Joint Board established seven categories representing various segments of the telecommunications industry and requested that candidates for membership be nominated according to category.<sup>4</sup> Nominations were due on October 15, 1997.<sup>5</sup> On February 23, 1998, the Joint Board requested additional nominations, which were due

on March 2, 1998.<sup>6</sup>

### **Issues to be Addressed by RTF**

The seventeen-member RTF is responsible for studying the establishment of a FLEC mechanism for rural telephone carriers. The primary purpose of the RTF is to consider whether a FLEC mechanism for rural carriers should have platform design features or input values that are different from those that are appropriate for non-rural carriers.<sup>7</sup> The RTF will also consider the appropriate timing of the transition to the FLEC mechanism for rural carriers. We also invite the RTF to offer its input on other issues relating to the implementation of high cost support mechanisms.

### **Organization of RTF**

The RTF shall meet as soon as practicable. At its first meeting, the RTF shall vote to select one of its members as chairperson. In addition, RTF members shall form three subgroups to focus on the following specific issues: platform design, input values, and the timing of the transition to the FLEC mechanism. The subgroups will report their findings to the full RTF.

### **Timing**

The RTF will present to the Joint Board a report that makes specific recommendations on the rural FLEC mechanism. The RTF must submit this report to the Joint Board nine months after the date on which the Commission implements a FLEC mechanism for non-rural carriers. The Joint Board will then file a report with the Commission evaluating the RTF's recommendations. The Joint Board's report should be filed before the Commission issues a Further Notice of Proposed Rulemaking on a FLEC mechanism for rural carriers.
