AN ACT

To amend sections 303 and 310 of the Communications Act of 1934, as amended, to provide that the Federal Communications Commission may issue authorizations, but not licenses, for alien amateur radio operators to operate their amateur radio stations in the United States, its possessions, and the Commonwealth of Puerto Rico provided there is in effect a bilateral agreement between the United States and the alien's government for such operation by United States amateurs on a reciprocal basis.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That subsection (1) of section 303 of the Communications
4 Act of 1934 (47 U.S.C. 303) is amended—

1 (1) by inserting “(1)” immediately after “(1)”;

2 and

3 (2) by adding at the end of such subsection the
4 following: “(2) Notwithstanding section 301 of this
5 Act and paragraph (1) of this subsection, the Com-
6 mission may issue authorizations, under such con-
7 ditions and terms as it may prescribe, to permit
8 an alien licensed by his government as an amateur radio
9 operator to operate his amateur radio station licensed by
10 his government in the United States, its possessions,
11 and the Commonwealth of Puerto Rico provided there
12 is in effect a bilateral agreement between the United
13 States and the alien’s government for such operation on
14 a reciprocal basis by United States amateur radio opera-
15 tors: *Provided*, That when an application for an author-
16 ization is received by the Commission, it shall notify the
