## **EMERGENCY ACCESS ADVISORY COMMITTEE ANNOUNCEMENT OF MARCH 1, 2013 MEETING**

### **Committee Focusing on Matters Pertaining to Next Generation 9-1-1 Access for Persons with Disabilities**

On December 7, 2010, Chairman Julius Genachowski announced the establishment and appointment of members and Co-Chairpersons of the Emergency Access Advisory Committee (EAAC),<sup>1</sup> an advisory committee required by the Twenty-First Century Communications and Video Accessibility Act of 2010 (CVAA).<sup>2</sup>

The next meeting of the EAAC will be held at the Federal Communications Commission (FCC or Commission) headquarters, 445 12<sup>th</sup> St., SW, Commission Meeting Room, Washington, DC, on Friday, March 1, 2013, from 10:30 a.m. to 3:30 p.m. (EST). All meetings are open to the public.

### **EAAC MISSION**

The purpose of the EAAC is to determine the most effective and efficient technologies and methods by which to enable access to Next Generation 911 (NG 9-1-1) emergency services by individuals with disabilities,<sup>3</sup> and to make recommendations to the Commission on how to achieve those effective and efficient technologies and methods.<sup>4</sup> During the spring of 2011, the EAAC conducted a nationwide survey of individuals with disabilities and released a report on that survey on June 21, 2011.<sup>5</sup> Following release of the survey report, the EAAC developed recommendations, which it submitted to the Commission on December 7, 2011, as required by the CVAA.<sup>6</sup> The agenda for the March 2013 EAAC meeting will include discussion of reports from the EAAC subcommittees and other activities needed to ensure access to 911 by individuals with disabilities.
