RENEWAL ONLY PURPOSE FOR PUBLIC SAFETY LICENSEES

If you are a **PUBLIC SAFETY LICENSEE** and you are planning to submit your renewal application by mail instead of online at <u>http://wireless.fcc.gov/uls</u>, please read this entire information letter before submitting your 'Renewal Only' application. In response to concerns raised about the number of pages that Public Safety Licensee manual filers receive in order to renew their applications, the FCC has prepared this fact sheet to assist licensees with completing and filing their FCC Form 601 (attached). For additional assistance, please call (877) 480-3201 (TTY 717-338-2824). To provide quality service and ensure security, all telephone calls are recorded.

All parties and entities (feeable and non-feeable) doing business with the Commission must obtain a unique identifying number called the FCC Registration Number (FRN) and supply it when doing business with the Commission. Failure to provide the FRN may delay the processing of the application. This requirement is to facilitate compliance with the Debt Collection Improvement Act of 1996 (DCIA).

INSTRUCTIONS FOR COMPLETION OF FCC FORM 601 FOR 'RENEWAL ONLY' ('RO')

For a 'Renewal Only' purpose, you may renew an existing authorization, Special Temporary Authority or developmental authorization that has not expired and where no changes in the license conditions are being requested at the time of renewal. Refer to 47 CFR §1.949 for FCC rules on timely filings (Renewals must be filed no later than expiration date of the authorization and no sooner than 90 days prior to expiration).
