**Meeting Minutes**

**Introduction of Participants:** Participants, including those participating by telephone introduced themselves.

**Approval of Agenda:** The agenda was approved.

**Approval of Minutes from December 13, 2001 meeting (Doc. IWG-2/031):** Document IWG-2/031 was approved as written.

**Consideration /Identification of Potential New IWG-2 Draft WRC-03 Proposals**

The chairman solicited from the attendees what they thought would need to be done between now and the June/July timeframe. There were comments made on a number of the agenda items including some status updates during the course of the discussion:

1. Agenda Item 1.4 - Proposal by RCS approved by IWG
2. Agenda Item 1.6 – The work on this agenda item appears to be mature and complete. People are satisfied with the package.
3. Agenda Item 1.15 – There have been two proposals made on 2 of the 3 issues. No proposal is anticipated on Resolution 604.
4. Agenda Item 1.16 – Expect a proposal on this agenda item. RCS is concerned that the preliminary view is outdated. RCS would welcome an update.

5. Agenda Item 1.20 – An attempt will be made to contact Leo 1 to determine if any more work will be done.
6. Agenda Item 1.31 – IWG-2 developed a proposal on Resolution 226 and commented on the RCS proposal on Resolution 227. If the conference does not make allocations under these Resolutions there may be additional work that needs to be done. IWG-2 identified the need to determine what to do with respect to possible additional spectrum for MSS. A comment was made that one way to solve the problem is to find an acceptable band pair. It was also pointed out that IWG-2 would have to consider Annex 4 of the band-by-band study to determine how the active services impact the passive services. (The existing text is in the Chairman's Report, Task Group 1-7/89)
7. Agenda Item 1.8.2 – Awaiting results of March 2002 meeting of ITU-R Task Group 1/7; Action TBD

#### **Status of Proposals and PVs Developed/Commented Upon by IWG-2 and WAC**

1. Agenda Item 1.4 – Comments on draft proposal reconciled. Paper is on the way to February 2002 CITEL PCC.III Meeting in Mexico.
2. Agenda Item 1.6 – There is an ongoing reconciliation effort between NTIA and the FCC.
3. Agenda Item 1.15 – There are approved proposals on Resolutions 605 and 606. Resolution 606 package has been completed. Reconciliation on Resolution 605 is anticipated this week.
4. Agenda Item 1.16 – RCS has a question on the “freshness” of view. FCC stated reservations in Notice of Proposed Rulemaking. The subsequent FCC Report and Order took a position consistent with FCC policy, which allowed it to enter reconciliation. The RCS did not develop a preliminary view on the item. IWG-2 would like to see the reconciliation completed so it can be brought to CITEL, since there has not been a lot of activity in this area.
5. Agenda Item 1.31 – IWG-2 sent a proposal on Resolution 226 and comments on Resolution 227. The preliminary views are in reconciliation and hopefully will be done in time for the Mexico CITEL meeting.

#### **Document IWG-2/032 (Doc. IWG-7/030) on WRC-03 Agenda Item 4**

The Chairman noted that there are some differences between the IWG-2 positions and some of the comments listed in the table. Recognizing that it is a work in progress the Chairman suggested that anyone who has a concern with any of the contents of the paper attend the IWG-7 meetings and make their comments directly rather than initiate a formal correspondence between working groups. Thus, the paper will be noted by IWG-2, but there will be no action taken as a working group.
