FINAL MINUTES

Minutes of the First Meeting of the FCC Advisory Committee for the 2007 World Radiocommunication Conference (WRC-07)

Meeting Summary:

1. **Opening Remarks**

Donald Abelson, Chief, International Bureau of the FCC, opened the meeting noting that the FCC relied on the advisory committee's recommendations when making decisions and that the FCC was very fortunate in the two leaders that the Chairman identified to lead this committee. He then introduced Nancy J. Victory and Peter Hadinger as the Chair and Vice-Chair of the WRC-07 Advisory Committee. Mr. Abelson also introduced the FCC staff that would be working with the advisory committee: Alex Roytblat, FCC's WRC Director; Kathryn O'Brien, Chief, Strategic Analysis and Negotiations Division; Jack Yachbes, legal advisor to the committee; and Don Weiland, administrative support for the committee.

Mr. Abelson remarked that there was a direct correlation between advance preparations and the success at World Radiocommunication Conferences and encouraged all those present to actively participate in the advisory committee and its informal working groups so that the work can be accomplished early.

Ms. Victory, noted that success at WRC-03 can be attributed to the consensus achieved on the vast majority of issues before going to the conference. Ms. Victory expressed hope that this committee would work on improving on the successes. She also noted a highly-capable team that had been put together to carry out the work of the committee. Mr. Hadinger thanked the FCC staff for bringing them up to speed before this first meeting and looked forward to the participation from the technical and legal experts present.

2. Approval of the Agenda

The agenda, Document WAC/001(30.01.04), was approved without change.

3. Report on Recent WRC-07 Preparatory Meetings

Mr. Roytblat introduced Document **WAC/002(30.01.04)** that summarized last fall's activities of the preparatory meetings of the CITEL PCC II Working Group for WRC-07 Preparations, the APT Conference Preparatory Group, and the CEPT ECC WRC-07 Preparatory Group. He remarked that regional positions played a vital role in the outcome of the last conference and encouraged participants to closely follow regional preparatory activities. Ms. Victory added that initially the activities of this committee will be geared to ensuring the United States' effective participation in regional WRC-07 preparatory meetings.

This document was noted for information.

4. Advisory Committee Structure

Ms. Victory presented Document **WAC/003(30.01.04)** setting forth the proposed structure of the advisory committee's five informal working groups and a list of the issues assigned to them. She then called each of the informal working group chairs to the podium to briefly present the issues that they would be addressing. In addition, the informal working group chairs introduced their Vice-Chairs (if present) and gave the dates, times and locations for their first meetings.

The structure document was approved.

5. Future Meetings

Mr. Roytblat introduced Document **WAC/004(30.01.04)**, a timeline setting forth the dates of national, regional, and international preparatory meetings leading up to WRC-07. He noted that the next CITEL PCC II WRC-07 Working Group meeting would be from March 29 through April 1 and that the initial work would be to prepare for that. Ms. Victory announced that the next meeting of the advisory committee was tentatively designated for March 4 (before CITEL), but it would be decided later whether there would be a need for the meeting or to postpone it until later in the spring. Mr. Hadinger urged participants to attend the first meetings of the informal working groups to get a good "reading of the tea leaves" with a view to getting proposals into the international fora early.

The timeline document was noted.

6. Other Business

There being no new business, Ms. Victory adjourned the meeting at 10:43 a.m.
