Objectives

This Working Group will develop recommendations for the CSRIC's consideration regarding any actions the FCC should take to improve the Emergency Alert System (EAS).

- ▶ State EAS Plans. Recommend steps to improve the process for developing and submitting state EAS plans to the Commission. Consider the formation and role of State Emergency Communications Councils (SECCs), and processes for optimizing the EAS while minimizing burdens on EAS stakeholders.
- **EAS Security**. Recommend actions to improve promote the security of the EAS.
- ▶ Nationwide EAS Test/Operational Issues. Address other EAS-related issues as assigned to CSRIC by the FCC.

Task #1: State EAS Plans

Recommend improvements for development and submission of State EAS plans, and FCC review.

Approach:

- Reduce burdens on SECCs and EAS Participants.
- Simple description of EAS alert dissemination.
- Verifiable by FCC.
- Issues:
 - Federal/State bifurcation at EAS alert entry point?
 - Dissemination maps?
 - Template or online forms?

Task #2: EAS Security

- Develop recommendations for enhancing the security of the EAS system.
- Next Steps:
 - Define scope and terminology of project.
 - Identify best practices for FCC to enhance integrity of EAS.
 - Consider relationship to Working Group #4 Cyber Security.
- Approach: Illustrate security considerations at all stages and links in the overall system, for both legacy EAS and CAP/EAS.
 - Consider practical, effective safeguards.

 - Government shutdown delay.

Task #3: Operational Issues & National Tests

- Develop proposals regarding technical issues that arose during the nationwide EAS test.
- Reviewed matrix of all questions in FCC Public Notice on nationwide EAS testing (rel. 9/23/13).
- Approach: Consider major issues raised in Notice:
 - Presidential alerts EAS header elements.
 - Visual crawls and audio accessibility.
 - National test event code and length.
 - Additional headers during alert processing.
 - FEMA's potential use of CAP for Presidential alerts.

Task #3: Operational Issues & National Tests

- Duration: Final Report June 2014.
- Commenced bi-weekly conference calls on October 1st.
