On June 9th, the M-Enabling Summit will also hold a session on the 21st Century Communication and Video Accessibility Act led by Karen Peltz Strauss, FCC Deputy Bureau Chief, Consumer and Governmental Affairs Bureau. This will be complemented by an all-day in-depth session for international delegates on policy and technology developments in the United States and internationally on June 11th with FCC staff at the FCC's Headquarters (445 12th Street, S.W./Washington D.C.).

The Federal Communications Commission (FCC) co-hosts the M-Enabling Summit, in cooperation with the Global Initiative for Inclusive Information and Communication Technologies (G3ict).
