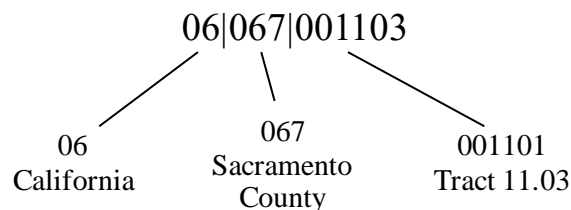


Census tracts and tract codes

Census tracts are geographic entities within counties (or the statistical equivalent of counties). The entire area of a county is covered by census tracts, just as the entire area of a state is covered by counties and county equivalents. There are 74,134 tracts defined for the 2010 census in the U.S. and its territories, and 85,158 tracts defined for the 2020 census.

Census tracts within a county are identified by a 4-digit basic code between 0001 and 9999, and may have a 2-digit suffix ranging from .01 to .98; for example, 6059.02. The decimal point separating the 4-digit basic tract code from the 2-digit suffix is shown in U.S. Census Bureau printed reports and maps. However, in computer-readable files prepared by the Census Bureau and for files uploaded for FCC Form 477, the decimal point is implied and does not appear.

A census tract code may not be used more than once in a single county, but it may be used again in a different county in the same state or in a county in a different state. Therefore, a particular census tract within the nation must be identified by: its state, its county, and its tract code. One way this is done by the Census Bureau and by the FCC is to identify a particular tract using an 11-digit code consisting of a 2-digit code for the state, a 3-digit code for the county (either of which may include one or more “leading” zeros), and 6 digits for the census tract (including any leading zeros, and also two “trailing” zeros in the many cases in which the basic tract code has no suffix). For example, the Office of the California Secretary of State, located at 1500 11th St, Sacramento, CA 95814, can be fully identified by the 11-digit code 06067001101, in which:



- 06 – identifies California,
- 067 – identifies Sacramento County within California, and
- 001103 – identifies Census Tract 11.01 within Sacramento County.

(The 2-digit state code and 3-digit county code are Federal Information Processing Standards (FIPS) codes. See, for example, https://www.census.gov/library/reference/code-lists/ansi.html#par_statelist, where selecting a state from the dropdown list will open a file showing both state and county FIPS codes for the selected state.)

Which tracts will the Form 477 filing interface accept as valid?

It depends. For the filing of **Fixed Broadband Subscription** data and **Fixed Voice Subscription** data, the Form 477 electronic filing system will recognize as valid the combinations of [State, County, and Census tract codes](#) from the 2020 Census. 2020 Census codes must be used for filings as of December 31, 2021 and after.

For filings through June 30, 2021, the Form 477 application will recognize as valid combinations of [State, County, and Census tract codes](#) from the 2010 Census.

Which addresses are in which tracts?

There are a variety of public resources and commercial products for matching a street address with the census tract in which it is located:

- The **Census Bureau** has a free address-matching (geocoding) tool that can provide the coordinates as well as the census geographies (state, county, tract and block) associated with addresses. The tool can be used for a single address or up to 1,000 addresses in batch mode. See <http://geocoding.geo.census.gov/geocoder/>. - **Texas A&M Geoservices** has a number of free tools available including batch geocoding of addresses and batch lookup of census geographies (“Census Intersection”).
