

**STATEMENT OF WORK (SOW) FOR
DIGITAL TELEVISION (DTV) TRANSITION
BASIC IN-HOME CONVERTER BOX INSTALLATION SERVICES
Region 6: Northeast (CT, DC, DE, MA, MD, ME, NH, NY, NJ, PA, RI, VT)**

1. INTRODUCTION AND BACKGROUND

The Federal Communications Commission (FCC) is in the final stage of implementing the congressionally mandated nationwide transition to digital broadcast television. Approximately one-third of the Nation's 1800 full-power television stations have already completed this transition. The remaining two-thirds of full-power broadcast television stations will transition on or before June 12, 2009.

In the television markets where the digital television (DTV) transition has been completed, the FCC has learned that most individuals and households can successfully make the transition by following instructions provided with their digital-to-analog converter box or by accessing mass media materials (such as information found on the FCC's and other entities' Internet sites, fact sheets and other printed materials available in libraries and community centers, calls to FCC or broadcast station help lines, or informational/demonstration programs presented by FCC staff, local television stations, and community groups).

From our experience with the early transitions in Wilmington and Hawaii, and on February 17, 2009, we have also learned that a small percentage of the population needs DTV transition assistance beyond that available through these means to successfully make the transition.

This request for quotation (RFQ) seeks proposals for basic, in-home digital-to-analog converter box installation services. Such services are composed of the following elements: connecting up to two of a household's existing coupon-eligible digital-to-analog converter boxes to existing broadcast antenna(s) and analog TVs, providing a basic level of orienting/reorienting the household's antenna(s) and scanning/rescanning the converter box(es) in order to receive digital broadcast TV stations in the area, and providing basic guidance to the consumer on the operation of their converter box(es).¹

Additionally, statistical evidence suggests that certain geographical areas of the country are less prepared than others. Thus, this solicitation also prefers proposals targeted to the geographical communities identified on the attached "Hot Spot" list – Attachment 1A. While proposals may address any geographic area that has not already fully transitioned (see Attachment 1B – Whole-Market Transitions as of February 18, 2009), proposals focusing on "Hot Spot" communities are preferred.

Finally, the Government is seeking proposals that focus on providing digital transition assistance to low-income individuals, minority communities, non-English speaking consumers, senior citizens, consumers living in rural areas or on tribal lands, and consumers with disabilities.

Proposals are requested from all potential offerors, both for-profit and non-profit entities that engage paid employees or volunteers to perform the stated services, regardless of whether they qualify as small business concerns or Historically Underutilized Business Zone (HUBZone) small business concerns under Small Business Administration regulations, 13 C.F.R. Parts 121 and 126. However, the FCC will make awards using cascading HUBZone and small business set-asides, as described in Method for Award—Cascading Set Asides, before considering awards to offerors other than small businesses.

2. OBJECTIVE

For more than a year, the FCC has been engaged in a nationwide initiative to increase awareness about the DTV transition and assist consumers in making the transition. This initiative includes information, outreach, and educational activities carried out by a mixture of FCC staff, broadcast station personnel, community volunteers, national social support and advocacy organizations, and contract vendors. The first phase of the nationwide DTV transition successfully concluded on February 17, 2009 when approximately one-third of the Nation's full-power broadcast television stations transitioned to all-digital broadcasting.

On February 17, 2009 the President signed the American Recovery and Reinvestment Act into law, which provided \$90 million for “for education and outreach...for programs to educate vulnerable populations, including senior citizens, minority communities, people with disabilities, low-income individuals, and people living in rural areas, about the transition and to provide one-on-one assistance to vulnerable populations, including help with converter box installation.”²

The FCC will undertake numerous activities designed to meet these statutory objectives. Many of these activities will be carried out by FCC employees, the National Telecommunications and Information Administration (NTIA), its grant recipients and volunteers. For the limited purposes described in this RFQ, the statutory provision to provide basic in-home installation assistance will be carried out by awardees of this solicitation.

3. SCOPE

The purpose and goal of this solicitation is to provide basic in-home digital-to-analog converter box installation services primarily to specific populations within geographic areas most in need of assistance.

While the FCC seeks proposals to serve all communities throughout the country, a preference will be given to proposals that serve geographic areas that we have identified as high-risk and in need of greater assistance (see attached “Hot Spot” list - Attachment 1A). Proposals for markets that have already fully transitioned will not be considered. (See Attachment 1B). Proposals should focus on providing transition assistance to low-income consumers, minority communities, non-English speaking consumers, senior citizens, consumers living in rural areas or on tribal lands, and consumers with disabilities.

This RFQ does not solicit and will not consider broader education and outreach proposals. Those matters will be handled through other means.

4. TASK - BASIC IN-HOME CONVERTER BOX INSTALLATION SERVICES FOR REGION 6

4.1. Contractor shall participate in an Orientation/Kick Off Meeting with the Contracting Officer Technical Representative (COTR) and the Technical Point of Contacts (TPOC) via teleconference.

4.2. Contractor shall establish procedures to provide basic in-home digital-to-analog converter box installation services. Procedures must include identification and security protocols, and provide documentation to verify each successful and unsuccessful in-home installation.

4.3. The Contractor shall provide the following in-home installation services: Connecting up to two (2) of a household's existing coupon-eligible digital-to-analog converter boxes to existing broadcast antenna(s) and analog TVs, providing a basic level of orienting/reorienting the household's antenna(s) and scanning/rescanning the converter box(es) in order to receive digital broadcast TV stations in the area, and providing basic guidance to the consumer on the operation of their converter box(es). A successful installation is defined as obtaining digital broadcast TV service from all or most of the broadcast stations previously received in analog at the household with the consumer's broadcast antenna(s) and analog TV(s).

4.4. Contractor shall provide basic in-home converter box installation services at least two weekdays (10 a.m. to 4 p.m.) and two weeknights (4 to 8 p.m.) per week and from 10 a.m. to 4 p.m. on Saturdays. In the 14 calendar days prior to June 12 and for 7 calendar days on and after June 12, in-home installation services must be provided on at least three weekdays (10 a.m. to 4 p.m.) and three weeknights (4 to 8 p.m.) per week and from 10 a.m. to 6 p.m. on Saturdays and Sundays.

4.5. Contractor shall communicate information about the availability and hours of the basic in-home digital-to-analog converter box installation services to local broadcasters, locally-assigned FCC employees, the FCC call center, and targeted population groups so that each might be able to either use or refer people to its services. The contractor shall respond to requests from individuals, FCC employees, broadcast stations, community groups, and elected officials to provide basic in-home installation services.

4.6. Contractor shall refer individuals with unsuccessful installations to the FCC point-of-contact (TBD) so those may be forwarded to other sources who carry out more technical and complex in-home installation services.

4.7 Contractor shall communicate on a regular basis (perhaps up to several times a day) with both the assigned COTR and TPOC(s).

5 STANDARD DELIVERABLES

5.1 Keep track of and provide reporting and documentation on how many installations were successfully completed, how many installations were not successfully completed; the reasons for unsuccessful installations; the time consumed during each installation (successful or unsuccessful); a summary of the major problems encountered in the installation process; and a total of how many referrals were made for technical, complex in-home DTV transition services. A successful installation is defined as obtaining digital broadcast TV service from all or most of the broadcast stations previously received in analog at the household with the consumer's broadcast antenna(s) and analog TV(s). Such reports will be required weekly from the time the contract is issued until the 14 calendar days prior to June 12. Between May 28 and June 19, such reporting will be required daily. Weekly reporting will resume from June 20 through the end of the contract.

5.2. Develop and provide for FCC review and approval the locations and procedures for the basic in-home installation services within one (1) week after award and prior to the kickoff meeting.

5.3. Copies of all communications used in accomplishing Task 4.5.

5.4. List of referrals for more technical and complex in-home installation services as described in Task 4.6.

5.5. Final basic in-home installation services report and invoice within 15 days of the end of the contract.

5.6. Deliverables shall be provided to FCC staff designated in Section 10. below via email or designated FCC link.

6. RECOVERY ACT REQUIREMENTS

(a) This procurement will be funded with funds from the American Recovery and Reinvestment Act of 2009 (Recovery Act) and the successful offerors and their first-tier subcontractors will be subject to the requirements of that statute, including requirements: (1) to provide access to representatives of the United States Government Accountability Office or the FCC's Office of Inspector General to examine records relating to the contract or subcontract; and (2) to submit quarterly reports including information on the expenditure of funds, completion status of the project, and an estimate of the jobs created or retained under the contract. Successful offerors will be required to submit their first quarterly report no later than July 10, 2009. The contracting officer will notify successful offerors of the required report format and other filing requirements prior to that date.

(b) Contracts awarded under this solicitation will include a clause (or clauses) specifying the contractors' Recovery Act compliance requirements in more detail. Successful offerors will be required to include this clause (or clauses) in all subcontracts that they award.

7. PERIOD OF PERFORMANCE

The period of performance shall be effective from the date of award (anticipated O/A May 2009) through July 31, 2009.

8. GENERAL

8.1 Scheduled Meetings:

The contractor is expected to conduct all meetings and communications with their COTR, communities they are serving, and other parties noted in section 4 in such a way as to incur only local or - at a maximum - regional travel costs.

However, it is possible that the Government may require representatives of the contractor to come to Washington to discuss work under the contract. If so, the Government will pay travel and per diem for such a required trip.

9. RESERVED

10. CONTRACTING OFFICER'S TECHNICAL REPRESENTATIVE (COTR) and TECHNICAL POINT OF CONTACT (TPOC)

The COTR for this Task Order shall be designated by the FCC. The COTR is responsible for the overall evaluation of contractor performance and deliverables for this Task Order. The FCC shall designate a TPOC for this Task Order. The TPOC shall provide guidance and expertise in business and operational functions of this requirement, and, serve as the subject matter expert for functional aspects of Task Order.

The COTR shall serve as the primary Point of Contact within the FCC and the TPOC shall serve as the alternate point of contact. The COTR is responsible for administrating the performance of work under this contract. **No understanding, agreement, modification, change order or other matter deviating from the terms and conditions of this contract is effective or binding upon the Government unless authorized by a modification signed by the Contracting Officer prior to the completion of the contract. The Contracting Officer shall be informed as soon as possible of any actions or inactions by a contractor or the Government which may affect the price or required delivery or completion times stated in the contract, so that the contract may be modified if necessary. The COTR and/or TPOC are not authorized to direct any action that results in a change in scope, price, terms, or conditions of this contract.**

11. INVOICES

11.1 A separate invoice for each month of services shall be submitted either electronically or via mail by the 10th of every month. **Weekly invoicing will be accepted from small businesses and/or small organizations:**

- (c) A courtesy copy shall be sent to the COTR via email.

11.2 Submission of invoices:

The invoice shall detail the services rendered, the period of performance, and include all required work tickets (Attachment 2) to verify the installations.

The invoice shall contain a statement signed by a responsible official of the concern substantially similar if not identical to the following:

I certify that the items above have been delivered in accordance with the contract, and that all charges are true, correct, and have not been previously billed.

Contractor's Signature

The Commission will return all improper invoices without action.

(a) Interest on Overdue Payment

Determination of interest due will be made in accordance with the provisions of the Prompt Payment Act and Office of Management and Budget Circular A-125.

(c) Payment due date:

- (1) Unless otherwise specified in the contract, payments under this contract will be made on the 30th calendar day after the later of
 - (i) The date of actual receipt of a proper invoice in the office designated to receive the invoice, or
 - (ii) The date tasks are formally accepted by the Government.
- (2) If the services covered by a submitted invoice are rejected for failure to conform to the technical requirements of this contract, the provisions stated above will apply to the properly resubmitted document.

12. PAYMENTS

Contractor shall be paid only for installations performed, whether successful or unsuccessful, and limited to one visit per household within its proposed demographic and geographic areas. Payment will be made in accordance with the unit price in the contract.

13. CLAUSES

52.212-4 Contract Terms and Conditions—Commercial Items (Oct 2008)

(a) *Inspection/Acceptance.* The Contractor shall only tender for acceptance those items that conform to the requirements of this contract. The Government reserves the right to inspect or test any supplies or services that have been tendered for acceptance. The Government may require repair or replacement of nonconforming supplies or reperformance of nonconforming services at no increase in contract price. If repair/replacement or reperformance will not correct the defects or is not possible, the Government may seek an equitable price reduction or adequate consideration for acceptance of nonconforming supplies or services. The Government must exercise its post-acceptance rights—

(1) Within a reasonable time after the defect was discovered or should have been discovered; and

(2) Before any substantial change occurs in the condition of the item, unless the change is due to the defect in the item.

(b) *Assignment.* The Contractor or its assignee may assign its rights to receive payment due as a result of performance of this contract to a bank, trust company, or other financing institution, including any Federal lending agency in accordance with the Assignment of Claims Act ([31 U.S.C. 3727](#)). However, when a third party makes payment (e.g., use of the Governmentwide commercial purchase card), the Contractor may not assign its rights to receive payment under this contract.

(c) *Changes.* Changes in the terms and conditions of this contract may be made only by written agreement of the parties.

(d) *Disputes.* This contract is subject to the Contract Disputes Act of 1978, as amended ([41 U.S.C. 601-613](#)). Failure of the parties to this contract to reach agreement on any request for equitable adjustment, claim, appeal or action arising under or relating to this contract shall be a dispute to be resolved in accordance with the clause at FAR [52.233-1](#), Disputes, which is incorporated herein by reference. The Contractor shall proceed diligently with performance of this contract, pending final resolution of any dispute arising under the contract.

(e) *Definitions.* The clause at FAR [52.202-1](#), Definitions, is incorporated herein by reference.

(f) *Excusable delays.* The Contractor shall be liable for default unless nonperformance is caused by an occurrence beyond the reasonable control of the Contractor and without its fault or negligence such as, acts of God or the public enemy, acts of the Government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, unusually severe weather, and delays of common carriers. The Contractor shall notify the Contracting Officer in writing as soon as it is reasonably possible after the commencement of any excusable delay, setting forth the full particulars in connection therewith, shall remedy such occurrence with all reasonable dispatch, and shall promptly give written notice to the Contracting Officer of the cessation of such occurrence.

(g) *Invoice.*

(1) The Contractor shall submit an original invoice and three copies (or electronic invoice, if authorized) to the address designated in the contract to receive invoices. An invoice must include—

(i) Name and address of the Contractor;

(ii) Invoice date and number;

(iii) Contract number, contract line item number and, if applicable, the order number;

(iv) Description, quantity, unit of measure, unit price and extended price of the items delivered;

(v) Shipping number and date of shipment, including the bill of lading number and weight of shipment if shipped on Government bill of lading;

(vi) Terms of any discount for prompt payment offered;

(vii) Name and address of official to whom payment is to be sent;

(viii) Name, title, and phone number of person to notify in event of defective invoice; and

(ix) Taxpayer Identification Number (TIN). The Contractor shall include its TIN on the invoice only if required elsewhere in this contract.

(x) Electronic funds transfer (EFT) banking information.

(A) The Contractor shall include EFT banking information on the invoice only if required elsewhere in this contract.

(B) If EFT banking information is not required to be on the invoice, in order for the invoice to be a proper invoice, the Contractor shall have submitted correct EFT banking information in accordance with the applicable solicitation provision, contract clause (e.g., [52.232-33](#), Payment by Electronic Funds Transfer—Central Contractor Registration, or [52.232-34](#), Payment by Electronic Funds Transfer—Other Than Central Contractor Registration), or applicable agency procedures.

(C) EFT banking information is not required if the Government waived the requirement to pay by EFT.

(2) Invoices will be handled in accordance with the Prompt Payment Act ([31 U.S.C. 3903](#)) and Office of Management and Budget (OMB) prompt payment regulations at 5 CFR Part 1315.

(h) *Patent indemnity.* The Contractor shall indemnify the Government and its officers, employees and agents against liability, including costs, for actual or alleged direct or contributory infringement of, or inducement to infringe, any United States or foreign patent, trademark or copyright, arising out of the performance of this contract, provided the Contractor is reasonably notified of such claims and proceedings.

(i) *Payment.*—

(1) *Items accepted.* Payment shall be made for items accepted by the Government that have been delivered to the delivery destinations set forth in this contract.

(2) *Prompt payment.* The Government will make payment in accordance with the Prompt Payment Act ([31 U.S.C. 3903](#)) and prompt payment regulations at 5 CFR Part 1315.

(3) *Electronic Funds Transfer (EFT).* If the Government makes payment by EFT, see [52.212-5\(b\)](#) for the appropriate EFT clause.

(4) *Discount.* In connection with any discount offered for early payment, time shall be computed from the date of the invoice. For the purpose of computing the discount earned, payment shall be considered to have been made on the date which appears on the payment check or the specified payment date if an electronic funds transfer payment is made.

(5) *Overpayments.* If the Contractor becomes aware of a duplicate contract financing or invoice payment or that the Government has otherwise overpaid on a contract financing or invoice payment, the Contractor shall—

(i) Remit the overpayment amount to the payment office cited in the contract along with a description of the overpayment including the—

(A) Circumstances of the overpayment (e.g., duplicate payment, erroneous payment, liquidation errors, date(s) of overpayment);

(B) Affected contract number and delivery order number, if applicable;

- (C) Affected contract line item or subline item, if applicable; and
- (D) Contractor point of contact.

(ii) Provide a copy of the remittance and supporting documentation to the Contracting Officer.

(6) *Interest.*

(i) All amounts that become payable by the Contractor to the Government under this contract shall bear simple interest from the date due until paid unless paid within 30 days of becoming due. The interest rate shall be the interest rate established by the Secretary of the Treasury as provided in Section 611 of the Contract Disputes Act of 1978 (Public Law 95-563), which is applicable to the period in which the amount becomes due, as provided in (i)(6)(v) of this clause, and then at the rate applicable for each six-month period as fixed by the Secretary until the amount is paid.

(ii) The Government may issue a demand for payment to the Contractor upon finding a debt is due under the contract.

(iii) *Final decisions.* The Contracting Officer will issue a final decision as required by [33.211](#) if—

(A) The Contracting Officer and the Contractor are unable to reach agreement on the existence or amount of a debt within 30 days;

(B) The Contractor fails to liquidate a debt previously demanded by the Contracting Officer within the timeline specified in the demand for payment unless the amounts were not repaid because the Contractor has requested an installment payment agreement; or

(C) The Contractor requests a deferment of collection on a debt previously demanded by the Contracting Officer (see [32.607-2](#)).

(iv) If a demand for payment was previously issued for the debt, the demand for payment included in the final decision shall identify the same due date as the original demand for payment.

(v) Amounts shall be due at the earliest of the following dates:

(A) The date fixed under this contract.

(B) The date of the first written demand for payment, including any demand for payment resulting from a default termination.

(vi) The interest charge shall be computed for the actual number of calendar days involved beginning on the due date and ending on—

(A) The date on which the designated office receives payment from the Contractor;

(B) The date of issuance of a Government check to the Contractor from which an amount otherwise payable has been withheld as a credit against the contract debt; or

(C) The date on which an amount withheld and applied to the contract debt would otherwise have become payable to the Contractor.

(vii) The interest charge made under this clause may be reduced under the procedures prescribed in [32.608-2](#) of the Federal Acquisition Regulation in effect on the date of this contract.

(j) *Risk of loss.* Unless the contract specifically provides otherwise, risk of loss or damage to the supplies provided under this contract shall remain with the Contractor until, and shall pass to the Government upon:

(1) Delivery of the supplies to a carrier, if transportation is f.o.b. origin; or

(2) Delivery of the supplies to the Government at the destination specified in the contract, if transportation is f.o.b. destination.

(k) *Taxes.* The contract price includes all applicable Federal, State, and local taxes and duties.

(l) *Termination for the Government's convenience.* The Government reserves the right to terminate this contract, or any part hereof, for its sole convenience. In the event of such termination, the Contractor shall immediately stop all work hereunder and shall immediately cause any and all of its suppliers and subcontractors to cease work. Subject to the terms of this contract, the Contractor shall be paid a

percentage of the contract price reflecting the percentage of the work performed prior to the notice of termination, plus reasonable charges the Contractor can demonstrate to the satisfaction of the Government using its standard record keeping system, have resulted from the termination. The Contractor shall not be required to comply with the cost accounting standards or contract cost principles for this purpose. This paragraph does not give the Government any right to audit the Contractor's records. The Contractor shall not be paid for any work performed or costs incurred which reasonably could have been avoided.

(m) *Termination for cause.* The Government may terminate this contract, or any part hereof, for cause in the event of any default by the Contractor, or if the Contractor fails to comply with any contract terms and conditions, or fails to provide the Government, upon request, with adequate assurances of future performance. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) *Title.* Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.

(o) *Warranty.* The Contractor warrants and implies that the items delivered hereunder are merchantable and fit for use for the particular purpose described in this contract.

(p) *Limitation of liability.* Except as otherwise provided by an express warranty, the Contractor will not be liable to the Government for consequential damages resulting from any defect or deficiencies in accepted items.

(q) *Other compliances.* The Contractor shall comply with all applicable Federal, State and local laws, executive orders, rules and regulations applicable to its performance under this contract.

(r) *Compliance with laws unique to Government contracts.* The Contractor agrees to comply with [31 U.S.C. 1352](#) relating to limitations on the use of appropriated funds to influence certain Federal contracts; [18 U.S.C. 431](#) relating to officials not to benefit; [40 U.S.C. 3701](#), *et seq.*, Contract Work Hours and Safety Standards Act; [41 U.S.C. 51-58](#), Anti-Kickback Act of 1986; [41 U.S.C. 265](#) and [10 U.S.C. 2409](#) relating to whistleblower protections; [49 U.S.C. 40118](#), Fly American; and [41 U.S.C. 423](#) relating to procurement integrity.

(s) *Order of precedence.* Any inconsistencies in this solicitation or contract shall be resolved by giving precedence in the following order:

- (1) The schedule of supplies/services.
 - (2) The Assignments, Disputes, Payments, Invoice, Other Compliances, and Compliance with Laws Unique to Government Contracts paragraphs of this clause.
 - (3) The clause at [52.212-5](#).
 - (4) Addenda to this solicitation or contract, including any license agreements for computer software.
 - (5) Solicitation provisions if this is a solicitation.
 - (6) Other paragraphs of this clause.
 - (7) The [Standard Form 1449](#).
 - (8) Other documents, exhibits, and attachments.
 - (9) The specification.
- (t) Central Contractor Registration (CCR).

(1) Unless exempted by an addendum to this contract, the Contractor is responsible during performance and through final payment of any contract for the accuracy and completeness of the data

within the CCR database, and for any liability resulting from the Government's reliance on inaccurate or incomplete data. To remain registered in the CCR database after the initial registration, the Contractor is required to review and update on an annual basis from the date of initial registration or subsequent updates its information in the CCR database to ensure it is current, accurate and complete. Updating information in the CCR does not alter the terms and conditions of this contract and is not a substitute for a properly executed contractual document.

(2)(i) If a Contractor has legally changed its business name, "doing business as" name, or division name (whichever is shown on the contract), or has transferred the assets used in performing the contract, but has not completed the necessary requirements regarding novation and change-of-name agreements in FAR [Subpart 42.12](#), the Contractor shall provide the responsible Contracting Officer a minimum of one business day's written notification of its intention to (A) change the name in the CCR database; (B) comply with the requirements of [Subpart 42.12](#); and (C) agree in writing to the timeline and procedures specified by the responsible Contracting Officer. The Contractor must provide with the notification sufficient documentation to support the legally changed name.

(ii) If the Contractor fails to comply with the requirements of paragraph (t)(2)(i) of this clause, or fails to perform the agreement at paragraph (t)(2)(i)(C) of this clause, and, in the absence of a properly executed novation or change-of-name agreement, the CCR information that shows the Contractor to be other than the Contractor indicated in the contract will be considered to be incorrect information within the meaning of the "Suspension of Payment" paragraph of the electronic funds transfer (EFT) clause of this contract.

“Small disadvantaged business concern” means a small business concern that represents, as part of its offer that—

(1) It has received certification as a small disadvantaged business concern consistent with 13 CFR part 124, Subpart B;

(2) No material change in disadvantaged ownership and control has occurred since its certification;

(3) Where the concern is owned by one or more individuals, the net worth of each individual upon whom the certification is based does not exceed \$750,000 after taking into account the applicable exclusions set forth at 13 CFR 124.104(c)(2); and

(4) It is identified, on the date of its representation, as a certified small disadvantaged business in the database maintained by the Small Business Administration (PRO-Net).

“Veteran-owned small business concern” means a small business concern—

(1) Not less than 51 percent of which is owned by one or more veterans (as defined at [38 U.S.C. 101\(2\)](#)) or, in the case of any publicly owned business, not less than 51 percent of the stock of which is owned by one or more veterans; and

(2) The management and daily business operations of which are controlled by one or more veterans.

“Women-owned small business concern” means a small business concern—

(1) That is at least 51 percent owned by one or more women, or, in the case of any publicly owned business, at least 51 percent of the stock of which is owned by one or more women; and

(2) Whose management and daily business operations are controlled by one or more women.

(d) Contractors acting in good faith may rely on written representations by their subcontractors regarding their status as a small business concern, a veteran-owned small business concern, a service-disabled veteran-owned small business concern, a HUBZone small business concern, a small disadvantaged business concern, or a women-owned small business concern.

This solicitation is open to all interested parties, both for-profit and non-profit, that engage paid employees or volunteers to perform the stated services. The **quote shall be provided electronically**, (via electronic mail attachment) and formatted for personal computers using Microsoft software and or Acrobat. **Offerors shall complete and submit the Quotation Cover Page (Enclosure 1), their Technical Capabilities (not to exceed three pages), the Price Quotation Page (Enclosure 2) and the Offeror Representations and Certifications (Enclosure 3).**

NOTE: All Proposals must be sent to eProposals@fcc.gov. Furthermore, the RFQ number and either of the business size designations of “SBA certified HUBZone small business”, “Small Business” or “Other” shall be included in the SUBJECT LINE of the email in order for any proposal to be considered responsive.

Proposals are requested from all potential offerors, regardless of whether they qualify as small business concerns or Historically Underutilized Business Zone (HUBZone) small business concerns under Small Business Administration regulations, 13 C.F.R.
