

AMENDMENT


The above-referenced application for transfer of control is hereby amended to revise the information reported in the Transferee's Exhibit 1, regarding interests in other FCC authorizations. Specifically, Exhibit 1 reported that Robert W. Pittman, the Co-Chief Operating Officer of AOL Time Warner Inc., is the Chairman and a member of the Board of Representatives of Roberts Radio L.L.C. ("Roberts Radio"), with a direct and indirect equity interest of approximately 16 percent in that company. At that time, Roberts Radio held a number of radio broadcast licenses through indirect subsidiaries.

Roberts Radio subsequently has consummated a number of license assignments granted by the Commission. At present, the only stations licensed to subsidiaries of Roberts Radio are as follows:
