On behalf of Time Warner Inc. ("Time Warner"), submitted herewith is an original and one copy of an update to Time Warner's September 14, 2000 letter on the status of local franchising authority approvals in connection with the America Online, Inc. ("AOL")/Time Warner merger.

Time Warner's September 14 letter reported that one community had not yet acted on the Form 394. That community has now granted its consent. The September 14 letter also reported that three communities had denied the Form 394 application. One of those communities has now reconsidered and granted its consent. Time Warner continues to urge the communities of Cary, North Carolina and Biddeford, Maine to also reconsider their denials.
