Royal & Sun Alliance cancel the insurance. I went to two other doctors who said I need a MRI on my low back. I get chronic pain in back and numbness and pain in legs. I also get spasms. The doctor want me to take meds they put me in a daze when I take them. I can not drive to work with the meds in my system. I can not do my job at a top level with the meds in my system I get wrote up for falling below par when the pain cause me to lose concentration.

I ask the judge to get the insurance co to pay for the MRI because the doctor request it., to find out why my legs go numb and why I have acute pain.

The lawyer for the insurance company ask the judge to refuse me the right to file for papers to get the MRI.

To me that is as bad as having the ALQuida in Afganistan stopping me from getting medical treatment!!!!!!!!!! We have military men dying over seas only to come back to America and be refused medical treatment if they get a job at Echostar Inc and get hurt on the job.

I was even refuse the right to use ice on my back at the orders of a workmans comp doctor by Scott Sutton and my old coach , When I went to Soraya H. Cartwright and told her about it so I could use ice to stop the inflammation and swelling I my back. She refuse to let me use ice. Soraya even told me maybe I should not be working for Echostar!!!!!!!!

I was told by the doctor not to open the heavy doors. He was to write a letter to Echostar request the guards open the doors. They refuse to do it. I went to Soraya that summer of 1999 the door were not opened for me and when I injured my back opening a office door they wrote me up and threaten to fire me. I caught up with Soraya in 2000 about 8 months later at which time she told the chief guard to open the door. even still alot of guards refused to open the doors. To this day they were told not to open the inter door for me!!!! By Bruno C. the Fac Manager.

I have been force to work over time, and force to do shift bids and moved
from desk to desk which is a cronic problem for my back!!!!
