Ms. Dortch:

Hughes Electronics Corporation ("Hughes") and General Motors Corporation ("GM") (collectively, the "Respondents") hereby provide supplemental information on one CD-Rom (Attachment 1) in response to the Commission's June 19, 2002, request for additional data as clarified during the Respondents' conference calls with the Commission on June 27 and July 17, 2002.

On July 9, 2002, the Respondents filed responsive data with the Commission, including monthly dealer payment information for the period from June 2001 through November 2001. In the *ex parte* filing, the Respondents indicated that they would provide additional data as soon as possible. Attached hereto is monthly dealer payment information for the period from January 1999 through May 2001 and for December 2001. The information is provided in the same manner and subject to the same considerations as described in the July 9 *ex parte* filing.

This filing, in conjunction with the July 2 and July 9, 2002 filings, provides the Commission with the information requested during the June 19 conference call. The data submitted includes: (i) subscriber information by tier of service, installation type, zip code, and ownership status, for the period from June 1999 through December 2001; (ii) new subscriber data by month, zip code, and dealer from whom equipment was purchased, for the period from

January 1998 through December 2001; and (iii) dealer payment information for the period from January 1999 through December 2001.
