DECLARATION

1. My name is Marta Samano. I am the President and CEO of the Academy of Latino Leaders in Action ("ALLA").
2. ALLA's mission is to empower and strengthen the infrastructure of the Latino grassroots community through organization and leadership development. ALLA has approximately 5,000 members, most of whom are alumni of ALLA's leadership and development programs. ALLA's members include parents, labor leaders, community leaders and religious leaders. The majority of ALLA's membership reside in the Los Angeles metropolitan area. ALLA's members have an interest in media diversity both as leaders who seek access to media to further their causes and as citizens who obtain information from the media.
3. I have reviewed the foregoing Petition to Deny. All of the relevant facts stated in the Petition are subject to official notice by the Federal Communications Commission, as they come from the transfer application itself, prior renewal applications, Commission and court decisions, or industry publications.
4. The proposed transaction harms ALLA and its membership in the following ways:
 - a. ALLA members will be harmed by the loss of diversity and competition that will result if Fox, which already holds the license for VHF television station KTTV, is permitted to acquire the license for a second VHF television, KCOP-TV in the Los Angeles metropolitan area.
 - b. ALLA members will be harmed by the decrease in diversity and competition if Fox is granted a 12 month waiver of the national ownership cap.
 - c. Because Fox's acquisition of eight affiliates of United Paramount Network (UPN), including the UPN in Los Angeles, will likely result in the demise of that network, ALLA members may be harmed by the loss of the diverse and minority-oriented programming aired on UPN.
5. This Declaration has been prepared in support of the foregoing Petition to Deny.
6. This statement is true to my personal knowledge and is made under penalty of perjury of the laws of the United States of America.


