Dear Ms. Zacharia:

On July 30, 2009, Frontier Communications Corporation (Frontier) and Verizon Communications Inc. (Verizon) filed a series of applications pursuant to sections 214 and 310(d) of the Communications Act of 1934, as amended,<sup>1</sup> seeking Commission approval for various assignments and transfers of control of licenses and authorizations.<sup>2</sup> In order for the Commission to complete its review of the applications and make the necessary public interest findings under sections 214 and 310(d), we require additional information and clarification of certain matters discussed in the applications

Accordingly, pursuant to sections 214 and 308(b) of the Act, we request that you provide all documents listed in the attached Supplemental Document Request. In order to expedite consideration of your application, please respond to the following requests pertaining to this proposed transaction by Tuesday, April 27, 2010.

Your responses should be filed with Marlene H. Dortch, Secretary, Federal Communications Commission, and should reference WC Docket No. 09-95. The Wireline Competition Bureau also should receive, at a minimum, two copies of all filings.<sup>3</sup>
