## PACIFIC WIRELESS TECHNOLOGIES, INC. AND NEXTEL COMMUNICATIONS, INC. SEEK CONSENT TO ASSIGN 800 MHZ LICENSES

Pacific Wireless Technologies, Inc. ("Pacific Wireless") and Nextel Communications, Inc. ("Nextel") have filed the following application under Section 310(d) of the Communications Act of 1934, as amended,<sup>1</sup> seeking Commission approval to assign 188 licenses from Pacific Wireless to Nextel.<sup>2</sup> The majority of these licenses are licensed in the Specialized Mobile Radio ("SMR") service. Some are licensed to the Business or Industrial/Land Transportation service, and these licenses are in the process of being converted to the SMR service. The service rules applicable to all of the licenses involved in the proposed transaction are found in Part 90 of the Commission's rules.
